The goal of the AQIP Action Project team on College Completion is to study and recommend the design of proactive, research-based student retention and completion strategies.

Students are faced with many challenges when attempting to obtain a certificate, degree or some other personal goal when attending East Central College. Early explorations and meetings with key players have already revealed that we have much more information to work with than we fully realized. One goal, then, will be to maximize our use of our own resources, including first figuring out just what sorts of information we have to work with, and then coordinating efforts to get the best completion and retention results possible.

Fall, 2014

- 1. Identify existing retention/completion strategies on campus. Define *current* student persistence and completion strategies that are specific to ECC, its programs, and its student populations.

- 2. Review and evaluate current ECC retention and graduation data

- 2. Develop benchmarks for the defined dashboard data points.

Fall, 2015

1. Identify new or expand current initiatives and/or strategies for successful retention/completion by researching and comparing current and emerging practice in evaluating and improving student persistence and retention.

1. Analyze effectiveness of the project, modify, and report results

solution(s).
