SUMMARY: Provide educational assistance to the students of East Central College.

ESSENTIAL TASKS: Employee must be able to perform the following functions to the satisfaction of the employee's supervisor.

Percentage of Time Frequency Description:

- 1. 70% Provide tutoring services.
- 2. 10% Answering phones, scheduling appointments and answering general knowledge questions.
- 3. 10% Attend Peer Tutoring course for CRLA certification and do required assignments.
- 4. 5% Perform general clerical work such as typing, filing, mailing and copying.
- 5. 5% Keep TLC area tidy by pushing in chairs and picking up stray trash.

MINIMUM KNOWLEDGE, SKILLS AND ABILITIES REQUIRED:

- 1. Must possess excellent interpersonal communication skills in order to assist students and visitors.
- 2. Must be recommended by no less than two (2) members of ECC faculty and one (1) ECC staff member.
- 3. Must have an A or B in course wanting to tutor or completed a higher level of the subject.
- 4. Must be willing to work evening hours.
- 5. Must possess a general clerical and technical work aptitude.
- 6. Knowledge of the Internet and computer software programs, including Microsoft Office Suite.
- 7. Must be able to work at least 15 hours per week.

QUALIFICATION REQUIREMENTS: Must be a student enrolled in at least 6 hours per semester; Must have a completed FAFSA form for the current academic year.

COMMUNICATION SKILLS: Ability to communicate clearly and concisely, both orally and in writing; ability to communicate effectively in a tactful and courteous manner with a variety of people, including students, employees, faculty, and the general public; ability to manage interpersonal conflict situations requiring tact, diplomacy and discretion.

OTHER KNOWLEDGE, SKILLS AND ABILITIES: Ability to accurately perform mathematical calculations; ability to apply common sense understanding to carry out instructions furnished in written, oral, and diagram form; ability to perform all essential functions using safe work methods and following safety regulations relating to job.
