SUMMARY: Provides general assistance to the Theatre department for four (4) productions per school year and additional performances such as The Christmas Celebration and The Actor's Showcase.

ESSENTIAL TASKS: Employee must be able to perform the following functions to the satisfaction of the employee's supervisor.

Percentage of Time Frequency Description:

- 1. 35% Perform general clerical work for the Theatre department such as copying, stuffing folders, hanging posters, running errands, returning phone calls.
- 2. 30% Organize and maintain prop and costume storage with paperwork related to rental/intake of props and costumes.
- 3. 10% Assist supervisor in planning rehearsal scheduling around actor and production team conflicts. Create and distribute schedule via email and website.
- 4. 10% Assist the Box Office student worker as needed.
- 5. 15% Assist with the creation of props and organization of backstage elements.

MINIMUM KNOWLEDGE, SKILLS AND ABILITIES REQUIRED:

- 1. Must possess excellent interpersonal communication skills in order to assist patrons and other students.
- 2. Must possess a general clerical and technical work aptitude.
- 3. Knowledge of the Internet.
- 4. Knowledge of computer software for word processing. Knowledge of Excel preferred.
- 5. Must be able to work at least 10 hours per week and work in at least 2-hour blocks of time.

QUALIFICATION REQUIREMENTS: *Must be a student enrolled in at least 6 hours per semester; Must have a completed FAFSA form for the current academic year.*

COMMUNICATION SKILLS: Ability to communicate clearly and concisely, both orally and in writing; ability to communicate effectively in a tactful and courteous manner with a variety of people, including students, employees, faculty, and the general public; ability to manage interpersonal conflict situations requiring tact, diplomacy and discretion.

OTHER KNOWLEDGE, SKILLS AND ABILITIES: Ability to accurately perform mathematical calculations; ability to apply common sense understanding to carry out instructions furnished in written, oral, and diagram form; ability to perform all essential functions using safe work methods and following safety regulations relating to job.
