OUR TITLE III AWARD: of a glance

Title III is a section of the Higher Education Act of 1965, and it pertains to institutional aid. Part A of Title III refers to strengthening institutions.

A **Title III Part A program** helps eligible institutions of higher education (IHEs) to become self-sufficient and expand their capacity to serve low-income students by providing funds to improve and strengthen the academic quality, institutional management, and fiscal stability of eligible institutions.

INITIATIVES, GOALS & STRATEGIES

THE PRIMARY INITIATIVES AT A GLANCE

ACHIEVING THE DREAM

A network membership that provides an opportunity for sustainable transformation toward a holistic model of advising & centers on providing students with wraparound services.

ACCELERATED STUDY IN ASSOCIATE PROGRAMS (ASAP)

This program will provide a gap tuition scholarship, book voucher, and food/gas subsidy in exchange for required utilization of wraparound supports. This will eliminate financial barriers for low-income students and allow them to focus solely on the successful completion of the courses.

SUPPLEMENTAL INSTRUCTION

This program will support students who have completed developmental courses & are working to complete gateway courses, as well as providing additional support to low-income students who may not be using the already robust learning center.

PROFESSIONAL DEVELOPMENT OPPORTUNITIES

A myriad of PD opportunities will come from the Title III grant, including those associated with Achieving the Dream & supplemental instruction, as well as best practices for online and hybrid teaching, retention practices, supporting low-income and underserved students, and more.

Overarching Goals & Strategies

AP GOAL 1: Increase course success and retention rates for underserved low-income students.

Join the Achieving the Dream network. Implement professional development for technology. Implement supplemental instruction (SI) program. Establish Accelerated Study in Association Programs (ASAP). Establish a holistic student support & advising model, including collaboration between Success Coaches & Advising.

Train advisors and success coaches in advising best practices with assistance from Achieving the Dream.

Hire additional staff to support a full range of student success needs.

Ensure adequate technology & training to expand HyFlex offerings from the current limited pilot program.

Enhance online course design & train faculty on HIPs for improving learning outcomes.

What was your favorite session at ATD?

Improving Credit Accumulation and Retention Through a Comprehensive and Focused Coaching Program

What is one major takeaway you can't stop thinking about?

The impact the ATD Coaches had on the institutions they worked with really resonated with me. It makes me really excited for our coaches to join us at ECC and continue the great work we do to help our students succeed.

What are you most excited to bring back to ECC?

I am excited to bring my renewed energy in ATD and our future coaches to ECC and my colleagues. I feel the presentations I attended showed thoughtful and engaging participation by ATD Coaches and the institutions with which they partnered. The colleges and ATD shared data driven decisions and outcomes from implementation to assessment of effectiveness. This just really renewed my excitement to have our own ATD Coaches and what changes we can implement to best support our students.

What was your favorite session at ATD?

"The Student Success Dividend: Holistic Support and Institutional Sustainability." It discussed the ways wise investments in student-centered resources and programs, when implemented well, can eventually pay for themselves via retention of current students and recruitment of prospective students due to a reputation of being successful and beneficial to both students and the institution.

What is one major takeaway you can't stop thinking about?

During the opening plenary session, we had the chance to hear from Dr. Imani Perry, a renowned professor of Women, Gender, & Sexuality and African American studies at Harvard. In her presentation, Dr. Perry shared a story of one of her many advisees whom she had seen experience great success. Of her student, she said, "In the conference language, that is, by achieving the dream,' you might think I'm referring to him matriculating at an elite institution with a doctorate. However, I'm really referring to the kind of person he's becoming." She went on to pose a guiding question she uses in her work, which is "Who do we take ourselves to be?" Dr. Perry stated that, "If we focus on ethos and act with integrity, we can feel confident that we've done righteous--albeit imperfect--work." I found this to be incredibly centering and a helpful question to keep at the heart of our work with students. We have to think of both parts--what do we want to help them achieve, and how can we help them become the best and most authentic versions of themselves.

I am absolutely thrilled to be a part of the 2024 Achieving the Dream annual DREAM conference. To see their experience from their lens keeps me thinking about what else do we not know about our students. The question I keep asking myself is what are the adversity that are students are facing, that we don't know about, and how can we get them to share their stories so we can use those as powerful motivators for change.
