Dear Angela:

This letter is to confirm and specify the terms of our engagement with EAST CENTRAL COLLEGE FOUNDATION INC for the preparation of the 2018 income tax return and to clarify the nature and extent of our services.

We will prepare the tax returns for 2018. We will not audit or otherwise verify the data you submit, although it may be necessary to request clarification of some of the information. We may provide you with questionnaires and/or worksheets to guide you in gathering the necessary information. Your use of such forms will assist in keeping pertinent information from being overlooked. We will render such accounting and bookkeeping assistance as determined to be necessary for preparation of the income tax returns.

It is your responsibility to provide all the information required for the preparation of complete and accurate returns. You should retain all the documents, canceled checks, and other data that form the basis of income and deductions. These may be necessary to prove the accuracy and completeness of the returns to a taxing authority. You have the final responsibility for the income tax returns and, therefore, you should review them carefully before you sign them.

Our work in connection with the preparation of your income tax return does not include any procedures designed to discover fraud, wrongdoing or other irregularities, should any exist. However, should we find any irregularities or unusual items, we will bring them to your attention. If we discover any errors or omissions on a prior year return, we will bring that to your attention. However, we cannot be responsible for identifying all items that may affect prior-year returns. If you become aware of such information, please contact us to discuss the best resolution of the issue.

You agree that if there is an error on the returns prepared from your data, we are not liable for either the payment of additional taxes that would have been properly due on the original returns, or any interest or penalties charged. We are however, liable for any penalty charged by the taxing authority as a result of incorrect payment of tax when the penalty results from an error in the preparation of the returns by us.

We will use professional judgement in resolving questions where the tax law is unclear, or where there may be conflicts between the taxing authorities' interpretations of the law and other supportable positions. Unless otherwise instructed by you, we will resolve such questions in your favor wherever possible.

The filing deadline for the tax return is November 15, 2019. It is your responsibility to provide us with your information with sufficient time to prepare an accurate tax return. If an extension of the time to file is required, any tax due with your return must be paid with that extension. Any amounts not paid by the filing deadline may be subject to interest and late payment penalties.

We may use independent contractors to assist us in preparing your tax return, but these preparers will not make substantive decisions concerning your tax return. We may share your information with these contractors, but remain committed to maintaining the confidentiality and security of your information.

In accordance with federal law, in no case will we disclose your tax return information to

any other third party for any purpose without first receiving your consent. We will notify you should we receive any request for the disclosure of privileged information from any third party, including a subpoena or IRS summons. In the event you direct us not to make the disclosure, you agree to hold us harmless from any expenses incurred in defending the privilege.

The law can impose penalties on both the preparer of a tax return and on the taxpayer. To avoid exposure to these penalties, it may be necessary in some cases to make certain disclosures to you and/or in the tax return concerning positions taken on the return that don't meet applicable standards. Accordingly, we will discuss tax positions that may increase the risk of exposure to penalties and any recommended disclosures with you before completing the return. If we conclude that we are obligated to disclose a position and you refuse to permit the disclosure, we reserve the right to withdraw from the engagement and you agree to compensate us for our services to the date of withdrawal.

The IRS permits you to authorize us to discuss, on a limited basis, aspects of your return for one year after the return's due date. Your consent to such a discussion is evidenced by checking a box on the return. Unless you tell us otherwise, we will check that box authorizing the IRS to discuss your return with us.

It is our policy to keep records related to this engagement for 5 years, after which we are free to destroy our copies. However, we do not keep any of your original records, so we will return those to you upon the completion of the engagement. When records are returned to you, it is your responsibility to retain and protect the records for possible future use, including potential examination by governmental or regulatory agencies.

Your return may be selected for review by the taxing authorities. In the event of an audit, you may be requested to produce documents, records, or other evidence to substantiate the items of income and deduction shown on your tax return. Any proposed adjustments by the examining agent are subject to certain rights of appeal. In the event of a tax examination, we will be available, upon request, to represent you. However, such additional services are not included in the fees for the preparation of the tax return.

Fees for our tax preparation services will be billed upon completion of your returns at the appropriate rate for the level and value of services rendered, plus out-of-pocket expenses. All invoices are due and payable upon presentation.

In the event of a dispute related in any way to our services, our firm and you agree to discuss the dispute and, if necessary, to promptly mediate in a good faith effort to resolve. We will share the mediator's fees and expenses equally. The mediation shall be confidential in all respects, as allowed or required by law.

We have the right to withdraw from this engagement, in our discretion, if you don't provide us with any information we request in a timely manner, refuse to cooperate with our reasonable requests or misrepresent any facts. Our withdrawal will release us from any obligation to complete your return and will constitute completion of our engagement. You agree to compensate us for our time and out-of-pocket expenses through the date of our withdrawal.

If the foregoing correctly sets forth your understanding of our tax engagement, please sign the efile authorization (Form 8879) and return it to our office. Your signature thereon indicates the acceptance of the terms discussed herein. This letter will remain in effect until canceled by either party and covers all other tax returns that we prepare for you. If you disagree with any of these terms, please notify us immediately.
