## **Criterion 3. TEACHING AND LEARNING: QUALITY, RESOURCES, AND SUPPORT**

ECC provides a high-quality education, wherever and however its offerings are delivered.

### **Evidence of our Teaching and Learning: Quality, Resources, and Support**

- ECC Guided Pathways – academic maps with a pattern of courses that students will complete within a certificate or degree program, to ensure a broad and appropriate educational experience. Cocurricular definition established, and assessment process aligned with other assessment practices.
- ECC articulates program, departmental, and institutional learning outcomes on academic websites and in course syllabi.
- General Education learning outcomes are ECC’s Institutional Student Learning Outcomes (ISLO’s): Communication, Critical Thinking, Social Responsibility, and Personal and Professional Development.
- ECC’s Hiring Process – Employee Selection Process, hiring process guidelines, longevity of employees supports quality teaching and learning.
- Support services (offered by qualified staff) for students, e.g., the Learning Center, Library, Access Services, Tutoring (whenever and however), Counseling, Financial Aid, Student Life, Falcon Career Center, etc.
- Student Organizations – e.g., PTK, Rotary, Student Nursing Association, SGA, Art Club, etc.
- Infrastructure – classroom upgrades, transition to Canvas to improve LMS platform, upgraded computer labs, group study rooms in library, computer and hot spot checkouts, etc.
- Faculty/Staff Training – professional development opportunities, Online Teaching and Learning Certification, etc.
- Academic Council – courses/programs review, New Program document with needs Analysis, advisory committee recommendations
- Faculty Credentialing process – faculty annually review credentialing process and all faculty (full-time, adjunct, and dual credit) are credentialed with the same process.
- Faculty and Staff evaluation process is systematic. Faculty process is assessed annually by faculty and academic leadership.
