funds.

- Assesses and maintains Quickbooks, Salesforce, and departmental credit card activity.
- Assists business clients with the Missouri One Start training programs through application and reimbursement processing, in addition to preparing ongoing and final reports.
- Works closely with the ECC Business Office to ensure auditing and rectifying of budgets is completed correctly
- Under the direction of the Executive Director, manages and maintains the Center for Workforce Development budgets.
- Assists with the delivery of Workkeys assessments to CWD clients.
- Conduct college business in a professional and ethical manner that includes the College's core values of integrity, diversity, empowerment, service, learning and collaboration.
- Communicate effectively in a professional, tactful and courteous manner with students, employees, faculty and the general public.
