SUMMARY: Track inventory and help organize the on-campus Food and Clothing Pantries.

ESSENTIAL TASKS: Employee must be able to perform the following functions to the satisfaction of the employee's supervisor.

- 1. Track entries of pantry request forms
- 2. Compile food or clothing packages for students as requested and communicate pickup times with student
- 3. Keep inventory of current pantry items
- 4. Organize pantry items into like categorizes/sizes
- 5. Shop or collect donations to restock pantries as needed
- 6. Assemble organizational equipment (first few days/weeks)
- 7. Creating outreach items such as flyers and social media post

MINIMUM KNOWLEDGE, SKILLS AND ABILITIES REQUIRED:

- 1. Ability to handle confidential information (FERPA)
- 2. Must possess strong customer service skills
- 3. Must enjoy working with a variety of people.
- 4. Must possess a general clerical work aptitude.
- 5. Knowledge of the internet, including social media
- 6. Knowledge of computer software for word processing.

QUALIFICATION REQUIREMENTS: Must be a student enrolled in at least 6 hours per semester; Must have a completed FAFSA form for the current academic year.

COMMUNICATION SKILLS: Ability to communicate clearly and concisely, both orally and in writing; ability to communicate effectively in a tactful and courteous manner with a variety of people, including students, employees, faculty, and the general public; ability to manage interpersonal conflict situations requiring tact, diplomacy and discretion.

College: Ability to perform all essential functions using safe work methods and following safety regulations relating to job; knowledge of the Family Educational Rights and Privacy Act (FERPA); knowledge of college policies, procedures, and practices;

EQUIPMENT AND SOFTWARE: Current information technology used by the college and department, including but not limited to, Microsoft Office, Outlook, etc.

PHYSICAL DEMANDS: The physical demands described here are representative of those that must be met by an employee to successfully perform the essential tasks of this job. The employee is regularly required to use hands for fine manipulation using a keyboard and mouse, handle or feel and reach with hands; and talk or hear. The employee is occasionally required to sit.
