POSITION SUMMARY: Responsible for the installation, configuration, maintenance, inventory, and security of technical resources, which includes servers, workstations (desktop and laptop computers), peripheral devices (printers, scanners, etc.), presentation systems, application software installed in classrooms, computer labs, offices, and work areas, and network systems and infrastructure at all Rolla locations. Responsible for performing a variety of maintenance related duties to support Rolla facility needs.

EDUCATION, EXPERIENCE, and LICENSES/CERTIFICATIONS: (comparable amount of training, education or experience may be substituted for the minimum qualifications)

Associate Degree in related field and 2 years directly related experience; must possess a valid driver's license. Additional training such as industry certifications including COMPTIA A+ or SERVER +, Microsoft MCP or MCSE is preferred.

ESSENTIAL TASKS: (Employee must be able to perform the following functions to the satisfaction of the employee's supervisor.)

- Install, configure, and maintain classroom & office workstations, and peripheral devices at ECC Rolla in accordance with established standards and procedures
- Perform the installation, upgrade, and maintenance of software applications and suites; ensure compliance with license agreements and copyright legislation at ECC Rolla
- Implement software utilities, install hardware devices, and develop procedures to ensure the security and reliability of equipment, software, and data resources at Rolla
- Acquire and maintain requisite technical skills to accurately diagnose and resolve problems and concerns associated with computer hardware, software, and peripheral devices at Rolla
- Consult with vendor support agencies as well as coworkers in the Information Technology Department at Union campus to resolve problems and determine equipment requirements.
- Provide user support (employees and students) for installed workstations, peripheral devices, and standard software applications; diagnose and resolve issues reported by academic and administrative users at Rolla
- Develop instructional materials and provide training for installed hardware and software specific to Rolla equipment
- Compile on-line and hardcopy operational, procedural, and informational documentation sets for equipment standards, configuration, inventory, troubleshooting, and repair procedures specific to Rolla equipment
- In collaboration with the network & system staff, install and configure network equipment; troubleshoot network problems at Rolla
 - evaluate network requirements and develop solutions toprovide the required services to Rolla
 - Provide support, diagnose, and resolve issues reported to the Help Desk by clients on the network
 - Install and maintain servers, network systems, and infrastructure in accordance with established standards and procedures
 - Install and maintain wireless controllers and access points at Rolla
- Regularly participate in training opportunities and Information Technology department meetings
- Maintain an accurate inventory of technical equipment located at Rolla, including system and software configurations and network addressing
- Work collaboratively and effectively with both the Rolla Director and IT Director to create and maintain a schedule for equipment updates/replacement at Rolla
- Serve as the proctor/facilitator and assist students as needed during open computer lab opportunities as needed
- Provide onsite facility support including:
 - Inspect buildings, electrical systems, grounds, doors, and equipment to ensure safe, well-maintained conditions, identify hazards, defects, and the need for adjustment or repair.
 - Perform basic maintenance tasks as needed including minor troubleshooting and repairs such as replacing light bulbs, assemble furniture, wall mount items, repair and replace locks on doors, operate a variety of hand tools.
 - Complete maintenance work orders as assigned and in a timely manner.

- Maintain inventory of tools, supplies, and equipment; recommend tools, supplies, and equipment for purchase.
- Ability to read, interpret and work from written assembly diagrams or oral instruction.
- Schedule and communicate with external service providers to address facility needs
- Conduct college business in a professional and ethical manner that includes the College's core values of integrity, diversity, empowerment, service, learning and collaboration.
- Communicate effectively in a professional, tactful and courteous manner with students, employees, faculty, and the general public.
