THIS PROPOSAL, made by \_\_\_\_\_ hereinafter called the Bidder, to **East Central College**, 1964 Prairie Dell Road, Union, Missouri 63084, hereinafter called the Owner, for **HANSEN HALL – THEATER REPAIRS** at East Central College, hereinafter called “the work”.

1. The undersigned, having examined and being familiar with the local conditions affecting the work and with the Contract Documents including the drawings, the Invitation for Bid, Instructions to Bidders, Statement of Bidder’s Qualifications, General Conditions, Special Conditions, and the body of technical specifications, including addenda number \_\_\_\_\_ through \_\_\_\_\_ inclusive, as issued by the Owner, hereby propose to furnish all labor and materials and perform work required for furnishing and installing all labor, materials, equipment, and transportation and everything necessarily inferred from the general nature and tendency of the plans and specifications for the proper execution of the aforementioned work as follows:

4. In submitting this bid, it is understood that the right is reserved by the Owner to reject any and all bids and it is agreed that the bids may not be withdrawn for a period of sixty days from the specified time for receiving bids.
5. Accompanying this bid is a certified check or cashier’s check in the amount of \_\_\_\_\_ Dollars (\$\_\_\_\_\_) or a 5% bid bond payable without condition to the Owner, which it is agreed shall be retained as liquidated damages for the delay and extra expense caused the Owner if the undersigned fails to execute the contract and furnish the Performance/Payment bond required by the contract documents.
6. The contract performance time is work to be completed by **August 12, 2016**. Work shall not commence prior to the Notice to Proceed. The contractor further agrees to pay to, or allow the Owner as liquidated damages the sum as stipulated in the Contract Form.

7. The Bidder hereby agrees to submit within 24 hours of Bid Date a list of sub contractors that will be used in the performance of the work:
- Note: Failure to list subcontractors for each category of work identified on the Proposal Form or the listing of more than one subcontractor for any category without designating the portion of work to be performed by each may result in rejection of the bid proposal. If the bidder intends to perform any designated subcontract work with the use of his own employees, the proposal shall make this fact clear.

That this proposal is genuine and is not made in the interest of or on behalf of any undisclosed person, firm, or corporation and is not submitted in conformity with any agreement of rules of any group, association, or corporation;  
That he has not directly or indirectly induced or solicited any other bidder to put in a false or sham proposal;  
That he has not solicited or induced any person, firm, or corporation to refrain from bidding;  
That he has not sought by collusion or otherwise to obtain for himself any advantages over any other bidder or over the Owner;  
That he will not discriminate against any employee or applicant for employment because of race, creed, color, or national origin in the performance of the work; and  
That all manufactured goods or commodities used or supplied in the performance of this contract or any subcontract thereto shall be manufactured, assembled, or produced in the United States in sufficient quantities to meet the contract requirements or cannot be manufactured, assembled, or produced in the United States within the necessary time in sufficient quantities to meet the contract requirements or that obtaining the product manufactured, assembled, or produced in the United States would increase the cost of the contract for purchase of the product by more than ten percent.

11. **Affidavit of Work Authorization and Documentation:** Pursuant to 285.530 RSMo, the Contractor must affirm its enrollment and participation in a federal work authorization program with respect to the employees proposed to work in connection with the services requested herein. The contractor should complete and submit the following two forms of documentation with the response. These two documents must be submitted prior to an award of a contract.

- 11.1 The contractor must submit a completed, notarized, Affidavit of Work Authorization.

AND

- 11.2 The contractor must submit documentation affirming the contractor's enrollment and participation in a federal work authorization program with respect to the employees proposed to work in connection with the **HANSEN HALL – THEATER REPAIRS**.

- 11.2.1 E-Verify is an example of a federal work authorization program. Acceptable E-verify enrollment and participation documentation consists of the following:

EITHER

- (a) From the E-Verify Memorandum of Understanding (MOU) Revised July 18, 2007, the contractor must submit both: 1) a valid, completed copy of the first page of the MOU identifying the contractor and 2) a valid copy of the MOU signature page completed by the contractor, the Social Security Administration, and the Department of Homeland Security – Verification Division.

OR

- (b) From the E-Verify Memorandum of Understanding (MOU) Revision Date 10/29/08, the contractor must submit the MOU signature page completed and signed by the contractor and the Department of Homeland Security – Verification Division. (The Social Security Administration is not signatory on the 10/29/08 MOU.)

By signature below, the contractor hereby affirms that all prices are quoted pursuant to the Terms and Conditions of **HANSEN HALL – THEATER REPAIRS**.

In addition, the contractor understands and certifies the following:

- The contractor shall only utilize personnel authorized to work in the United States in accordance with all applicable federal and state laws. This includes but is not limited to the Illegal Immigration Reform and Immigration Responsibility Act (IIRIRA) and INA Section 274A.
- If the contractor is found to be in violation of this requirement or the applicable state; federal and local laws and regulations, and if the State of Missouri has reasonable cause to believe that the contractor has knowingly employed individuals who are not eligible to work in the United states, the University shall have the right to cancel the contract immediately without penalty or recourse and suspend or debar the contractor from doing business with the University. The University may also withhold up to twenty-five percent of the total amount due the contractor.
- The contractor agrees to fully cooperate with any audit or investigation from federal, state or local law enforcement agencies.

In addition, the contractor shall maintain enrollment and participation in a federal work authorization program with respect to the employees working in connection with **HANSEN HALL – THEATER REPAIRS**.
