Two (2) Core Network switches to handle all Layer3 switching for the campus with the following minimum specifications

- Thirty-Two (32) 40Gbe QSFP+ port per switch
- Two ports per switch must be provide for connection to extended range switches at 1Gb using LR Optics/Transceivers
- Remaining Thirty-one (31) or greater switch ports must be capable of providing either 40Gbe connections or (4) 10Gbe connections at short range and feed connectivity for the Fiber Breakout Panels described herein
- Line rate L2 and L3 switching and routing
- 2.5 Tbps or great switching fabric in full-duplex
- 8+ queues per port
- Packet Buffer Memory of 12MB or greater
- Sub 700ns switching latency
- Must support reversible airflow
- Redundant Hot-Swapping power supplies

#### Support

All proposed equipment and switches must be new (not used or factory refurbished) and include at least 3years of manufacture onsite warranty and support with 7x24x365 Hardware and Software technical support assistance.

#### **Installation Services**

Respondents should include fees for installation, configuration, training, and day 2 supports services for the equipment constituting no less than 60 hours of onsite presence by a qualified network engineer that is manufacturer trained and certified to install the equipment.

#### **Bid Response Detail**

Bidders must provide a detailed bill of materials itemizing all components of the system, including switches, optics, power supplies, licensing, etc. Failure to do so will disqualify the respondent.
